Central A&M E-Learning Day Plans for Parents and Students 2025-2026 and 2026-2027

E-Learning is the use of technology to enable people to learn anytime and anywhere. E-Learning days will offer a blended learning environment for students. Teachers will create standards-based lessons with resources and the assignment that will be available through our website on each teacher's page or that will be sent home with students to work on during e-days.

Please read through the information provided below to ensure that you have a good understanding of expectations

FAQs

What are the E-Learning dates for the school year?

E-Learning days will be used when school is closed due to a shut down for any reason and closing due to inclement weather. Our E-learning days will be announced ahead of time if at all possible.

How will students and parents be notified if an E-Learning day will be used in the case of emergency school cancellation?

Families will be notified of E-Learning days just as they are notified of school delays and closings via Parent Square or on the Website. Check to make sure your contact information is correct.

What will it look like for students?

- *Student work will be in the Google Platform, IXL or another platform that the student has used in the classroom previously. The assignment will not use programming or apps that students are not familiar with or have not already used in class before.
- *Assignments will be somewhat equivalent to student "work time" when they are in class on a regular day.
- *If needed, teachers will provide parents with necessary codes to ease access and student username and password.
- *Teachers have worked with the students in class to make sure they are prepared for any E-Learning assignments.
- *PreK-5th grade students will most likely be given work on hard copy before an E-learning day.
- *Students in Grades 5-12 should make sure they have access to school email. Students will need to check their emails and follow the instructions to receive attendance credit for each individual teacher.

What happens if my child needs assistance?

Teachers will be available to students through their school email for email response during office hours from 8:00AM-10:00AM. They will be intermittently available through email from 10:00 AM until 3:00PM. Teacher emails can be found on the district's website under the Directory tab. https://www.camraiders.com

When will E-Learning day assignments get posted?

Work for students will be posted by 8:30 AM during emergency school cancellation days. Assignments will be graded and recorded. Consideration will be given to students that need additional time due to unforeseen circumstances.

What if we don't have Internet access at our home?

Accommodations will be made for students who do not have internet access. Please let your student's teacher know if the internet is not available to them and hard copy work will be available.

And while many assignments may require Internet, there are several options for families without Internet access:

- For some assignments the required files can be downloaded in advance while at school.
- For some assignments, the student may be able to do the actual thinking/writing process while at home and then quickly upload it when they return to school.
- Parents may consider other options, like taking their child to a family member or friend who has access or to one of the many places with free public access.

Note: students will not be penalized if they cannot get Internet service, but they will be responsible for completing the work requiring the Internet while at school.

How will attendance be taken?

Students must log in by 11:00 am on a google form provided to them. This form must be submitted to their teacher and the computer will provide a log in stamp. If a student is ill and cannot participate, parents should follow regular call-off procedures and contact the school office before 10am. Students are still responsible for completing the assignment.

Can a student work, go on a college visit, or shadow an employer during this day? Each student can organize his/her day in a manner that suits them. They will be required to complete all work before the class's next meeting but there is no specific time requirements

How will E-Learning day impact after school activities?

On an E-Learning day due to weather, after school activities will be treated the same as if school were closed. Notification of extracurricular activities will be sent by noon.
